Every party package includes use of the entire pool facility with restrooms, noodles, kick boards, and life guards. Picnic tables (4) are available outside of the pool area in the park. No alcohol is allowed in the parks. Refrigeration and access to electricity is available but all foods, paper goods and decorations need to be supplied. Aside from provided noodles and kick boards, no inflatable flotation devices or outside toys are allowed. At least two adults must accompany the group and any non-swimmers must be assisted directly in the water. Showers, changing rooms, and a trash receptacle are available. **Reynolds Pool** has a large pool with a 3 foot shallow end that gradually progresses to a 12 foot deep end with a diving board. **Greenwood Pool** has a large pool with a 2 ½ foot shallow end and deepens to 9 feet. Greenwood pool also has a mini-water slide and splash pad. Only SWIM DIAPERS are allowed in large pools.
